### Information on Voluntary Investments and Donations

#### NON-DEDUCTIBILITY PERCENTAGE

Compliance with the Tax Reform Act of 1993, as amended by the Tax Cuts and Jobs Act of 2017, requires that the portion of dues attributable to lobbying and political activities at the Local, State and Federal levels of government be considered nondeductible for income tax purposes.

For 2025, with ILLINOIS REALTORS<sup>®</sup> dues at \$212 and the RVOICE assessment at \$85 per member (a total of \$297), ILLINOIS REALTORS<sup>®</sup> computes 32 percent, or \$95.04, to be nondeductible for income tax purposes due to lobbying efforts by ILLINOIS REALTORS<sup>®</sup>. For 2026, with ILLINOIS REALTORS<sup>®</sup> dues at \$219 and the RVOICE assessment at \$85 per member (a total of \$304), ILLINOIS REALTORS<sup>®</sup> computes 32 percent, or \$97.28, to be nondeductible for income tax purposes due to lobbying efforts by ILLINOIS REALTORS<sup>®</sup>.

For 2025, with dues at \$156 per member, NAR computes 35 percent, or \$55, to be nondeductible for income tax purposes due to NAR's lobbying efforts. Please note that the entire \$45 Public Awareness Campaign special assessment qualifies as fully deductible. As always, the assessment is not prorated so new members who join throughout the year owe the full \$45. Note that the entire \$45 portion of dues related to Consumer Advertising Campaign qualifies as deductible dues.
